Admission Arrangements



Introduction

 In 2018 the BMAT STEM ACADEMY will participate in the co-ordinated admission arrangements operated by Essex County Council. Pupils will be required to apply for entry via the local authority in which they reside.

Admission numbers

2. For the admissions arrangements for BMAT STEM ACADEMY please see Appendix.

Consideration of applications

3. BMAT STEM ACADEMY will consider all applications for places. Where fewer than the published admission number for any relevant age group (years 10 and 11) are received, BMAT STEM ACADEMY will offer places to all those who have applied.

Special Educational Needs

4. Pupils with statements of Special Educational Needs (SEN), where BMAT STEM ACADEMY is named on the statement, will be admitted first.

The Oversubscription Criteria

- 5. After the admission of SEN pupils, and where the number of applications for admission is greater than the published admissions number, applications will be considered against the criteria below in the order in which they are set out.
 - a) "Looked After Children" and previously "Looked After Children" as defined in Section 22(1) of the Children Act 1989).:
 - b) Priority will be given to siblings; ie brothers or sisters of existing pupils with common parent(s) or step-siblings sharing the same home address. Applications from sets of twins or other children from multiple births will be treated as individual applicants, this may result in one child being allocated a place under random allocation and another not.
 - c) Up to 50% of remaining places allocated to applicants from postcodes CM17, CM18, CM19, and CM20 ("the Catchment"). If there are more Catchment applicants than the 50% places available, the places will be allocated by random allocation which will be independently verified.
 - d) The remaining places will be allocated to pupils living outside the Catchment, with those living closest to the BMAT STEM ACADEMY (as the crow flies) being prioritised.

If places remain unfilled after (d) (pupils living outside the Catchment), then they will re-allocated to pupils living within the Catchment by independently verified random allocation.

Definitions

6. In determining which applicants live closest to the BMAT STEM ACADEMY, distances from home to school will be measured in a direct line between the visual centre of the applicant's home address point and the reception within the main BMAT STEM ACADEMY building (using the Local Authority's computerised mapping system).

- 7. In the event that we are unable to distinguish between applicants for the final available place, such as in the case of students who live in the same block of flats, then the final place will be made through random allocation which will be independently verified.
- 8. The applicant's home address is the home address as registered with the Doctor.

Arrangements for admitting pupils to other year groups, including to replace any pupils who have left BMAT STEM ACADEMY.

9. With regards to the admission arrangements relating to applications submitted for years other than the normal year of entry, the Academy will consider all such applications and if the year group applied for has a place available admit the applicant. If more applications are received than there are places available, the oversubscription criteria in paragraph 4 a-d shall apply. Parents of pupils whose applications are turned down are entitled to appeal.

Waiting list

- 10. Subject to any provisions regarding waiting lists in the LA's co-ordinated admission scheme, the Academy will operate a waiting list. Where in any year BMAT STEM ACADEMY receives more applications for places than there are places available, a waiting list will operate until the end of the Autumn term. This will be maintained by BMAT STEM ACADEMY and it will be open to any parent to ask for his or her child's name to be placed on the waiting list, following an unsuccessful application.
- 11. An applicant's position on the waiting list will be determined solely in accordance with the oversubscription criteria set out in paragraph 5 a-d. Where places become vacant they will be allocated to those on the waiting list in accordance with the oversubscription criteria.

Appeals

- There will be a right of appeal to an Independent Appeals Panel for internal pupils refused transfer and external applicants refused admission. Details of the appeals process will be published on the BMAT STEM ACADEMY's website and contained within the letter notifying the pupil of the decision not to offer a place.
- 13. The appeals process will be run in line with statutory duties of the school admission appeals code.

For entry to year 10 from September 2018, the BMAT STEM ACADEMY will use Essex County Council's timetable for applications each year (exact dates may vary from year to year) to fit in with the timetable for the co-ordination of admission arrangements.

Late Applications

- 14. Applications received after the closing date will only be considered alongside those applicants who have applied on time if there are exceptional reasons for missing the deadline e.g. a major change of circumstances.
- 15. A late application will not affect the right of appeal or the right to be placed on the waiting list.
- 16. Late applications will only be considered only after on-time applications and if places are still available. All late applications will be placed on a waiting list unless they fulfil the criteria to be considered alongside applicants who have applied on time.
